Eligibility Criteria for B.Com. Honours, 2021-22:

<p>1. A candidate taking up B. Com Honours Course in Finance or Marketing must obtain:</p> <p>(i) A minimum of 50% marks in aggregate and 45% in the subject or related subject at the previous qualifying examination.</p> <p style="text-align: center;">OR</p> <p>(ii) 55% marks in the subject or related subject at the previous qualifying examination.</p>	
<p>2. A Candidate shall be allowed to take up B. Com. Hons. Course under heading 'A' if he / she had passed any one of the following subjects under heading 'B', at the previous qualifying examination.</p>	
A. Honours in	B. Subject or Related Subject
B.Com. (Finance or Marketing)	Accountancy, Business Economics including Business Mathematics, Business Organization, Mathematics, Economics, Statistics, Commerce, Accounts, Business Studies, Financial Accounting, Office Management and Secretarial Practice, Elements of Cost Accountancy and Auditing, Book Keeping, Business Mathematics, Cost Accountancy and Principles of Management

However, candidates belonging to the Scheduled Castes or Scheduled Tribe community taking up Honours Course of study must have obtained a minimum of 40% marks in the aggregate and 40% marks in the subject or related subjects at the previous qualifying examinations, as the case may be. Eligibility Criteria for B. Sc. Honours, 2021-22:

<p>1. A Candidate taking up Honours Course in B. Sc. Stream (Geography or Economics) must obtain:</p> <p>(i) A minimum of 50% marks in aggregate and 45% in the subject or related subject at the previous qualifying examination.</p> <p>OR</p> <p>(ii) 55% marks in the subject or related subject at the previous qualifying examination.</p>	
<p>2. A Candidate shall be allowed to take up B. Sc. Hons. under heading 'A', if, he / she had passed any one of the following subjects under heading 'B', at the previous qualifying examination:</p>	
A. Honours in	B. Subject or Related Subject
Geography	Geography, Mathematics, Statistics
Economics	Mathematics

However, candidates belonging to the Scheduled Castes or Scheduled Tribe community taking up Honours Course of study must have obtained a minimum of 40% marks in the aggregate and 40% marks in the subject or related subjects at the previous qualifying examinations, as the case may be. Eligibility Criteria for B.A. Honours, 2021-22:

1. A candidate taking up Honours Course in B. A. Stream (Bengali, English, Education, History, Economics & Journalism and Mass Communication) must obtain:

(i) A minimum 50% marks in aggregate and 45% in the subject or related subject at the previous qualifying examination.

OR

(ii) 55% marks in the subject or related subject at the previous qualifying examination.

2. A Candidate shall be allowed to take up B.A. Hons. Course under heading 'A', if, he / she had passed any one of the following subjects under heading 'B', at the previous qualifying examination:

A. Honours in	B. Subject or Related Subject
Bengali	Bengali
English	English
Economics	Mathematics
Education	Education, Psychology, Philosophy, Sociology, Economics, Political Science, History, Mathematics
History	History
Journalism & Mass Communication	English, Bengali

3. However, candidates belonging to the **Scheduled Castes or Scheduled Tribe** community taking up Honours Course of study must have obtained a minimum of **40% marks in the aggregate and 40% marks in the subject or related subjects** at the previous qualifying examinations, as the case may be. Any dispute regarding eligibility criteria would be resolved by the equivalence Committee set up by the West Bengal State University

Eligibility Criteria for B.A./ B.Sc/ B.com General, 2021-22:

The Candidates passing **Higher Secondary** or Equivalent Examination either in General stream or in **Vocational Stream** or passed from **Rabindra Mukta Vidyalaya** or **National Open School** recognized by the Distant Learning Council are eligible for the admission to General Stream.

A Candidate shall be allowed to take up General Course under heading 'A' if he / she had passed any one of the following subjects under heading 'B', at the previous qualifying examination.

A: General Course in	B: Subject
B. A.	English, Bengali (Students from any stream can apply in B. A. General Course if he/she passed Bengali or English in previous qualifying Examination)
B. Sc	Physics, Zoology, Chemistry, Botany, Psychology, Mathematics, Molecular Biology, Statistics, Microbiology, Anthropology, Geography, Physiology, Economics, Computer Science, Electronics, Bio Chemistry, Environmental Science, Food & Nutrition
B. Com	Accountancy, Business Economics including Business Mathematics, Business Organization, Mathematics, Economics, Statistics, Commerce, Accounts, Business Studies, Financial Accounting, Office Management and Secretarial Practice, Elements of Cost Accountancy and Auditing, Book Keeping, Business Mathematics, Cost Accountancy and Principles of Management
